Reference is invited to para III on the subject of "Net Realisation Rate (NRR)" of Bureau's Notification No. 783 dated 15<sup>th</sup> November 2007. As you are aware, Net Realisation Rate (NRR) is the term used for value of newspaper in waste per kg. as fixed by the Council from time to time.
